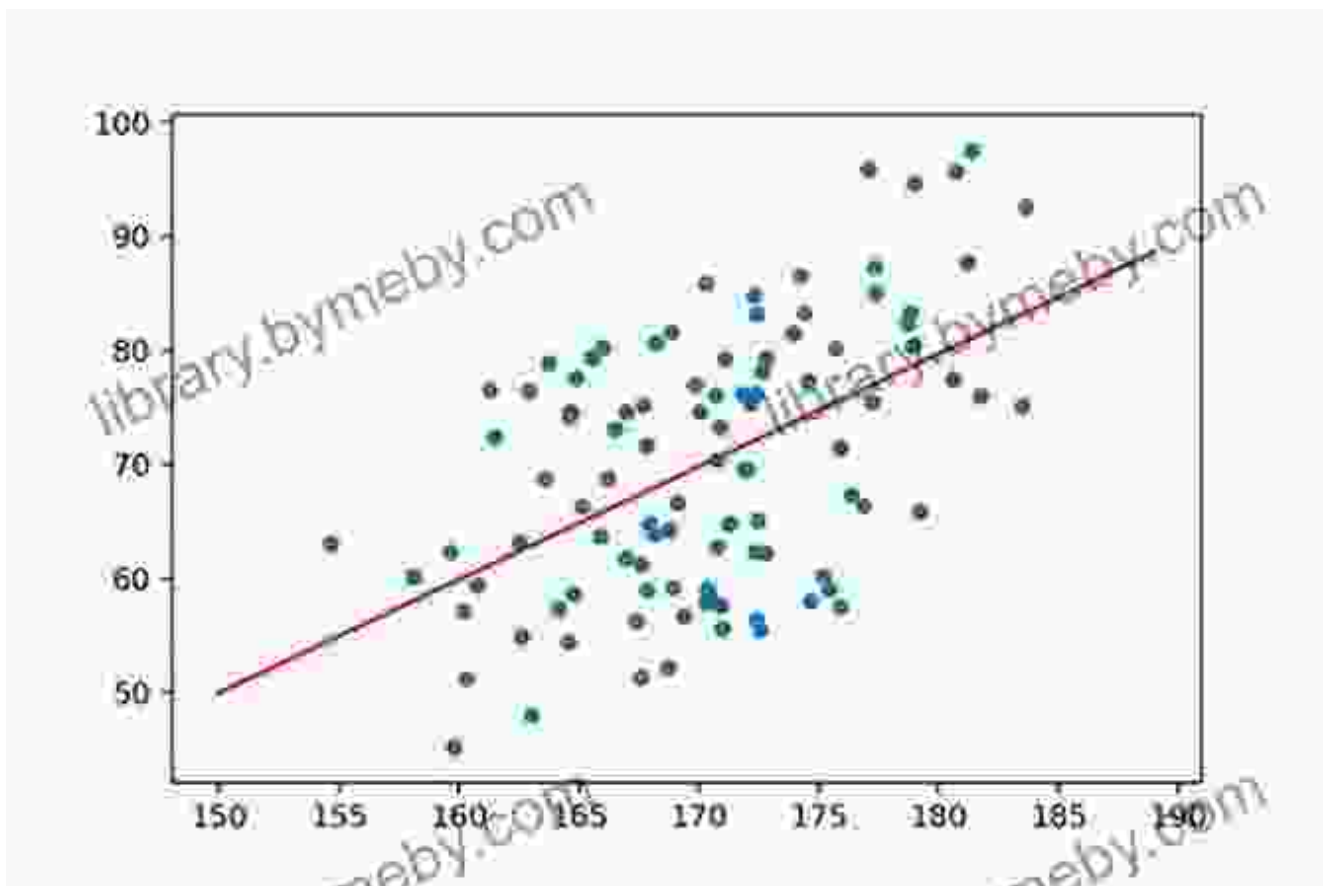

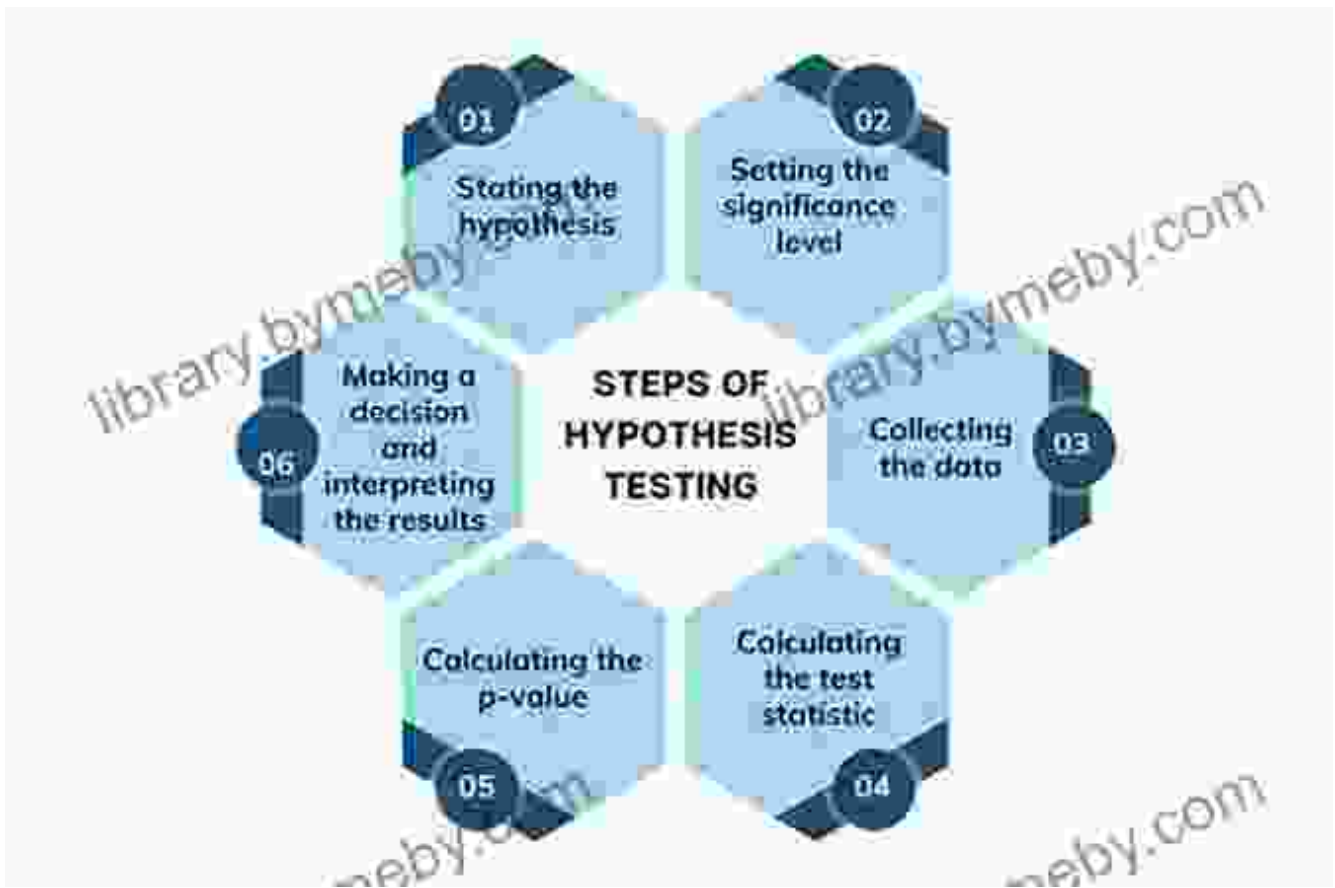

Regression Analysis Scatterplot

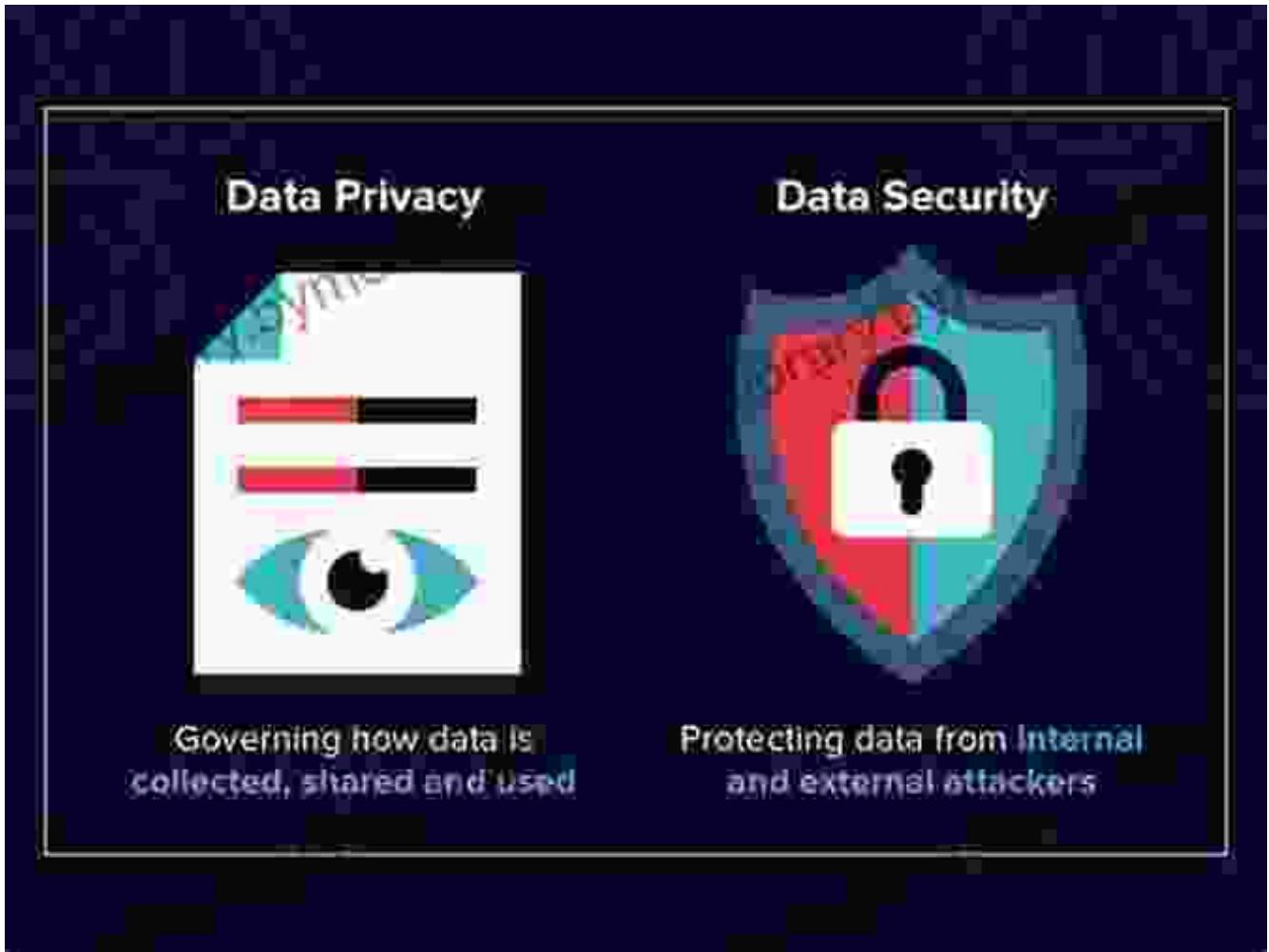
